Please admit the attached ABACO bills are true and correct copies of bills sent by ABACO for propane delivered to the Shoshone Condominium Hotel.


RESPONSE:

ABACO admits the bills attached to SCHOA-036 are true and correct copies of bills that ABACO sent to Boyne, USA for service to the Shoshone Lodge Propane Meter for service provided by ABACO to Boyne, USA in each of the months of June 2009 through May 2011.

ABACO asserts these billing statements were sent to Boyne, USA pursuant to the contractual agreement between ABACO and Boyne, USA; that Boyne, USA owed ABACO for the services provided; and that ABACO does not provide service to and does not bill the Shoshone Condominium Hotel Owner's Association or any individual unit owners within the Shoshone Condominium Hotel for any service. Any payment obligations between the Shoshone Condominium Hotel Owners Association or any individual unit owners are agreements solely between the individual unit owners and the Shoshone Condominium Hotel Owners Association and/or Boyne, USA; or between the Shoshone Condominium Hotel Owners Association and Boyne, USA. Neither the Shoshone Condominium Hotel Owners Association nor any individual unit owners are customers of ABACO, and ABACO has no say in the amounts charged by Boyne to the Shoshone Condominium Hotel Owners Association or any individual unit owners for propane supply, delivery, service, or maintenance.
